The COVID-19 pandemic has forced the healthcare industry to adapt to new ways of doing business, creating new financial and healthcare delivery issues that are challenging conventional thinking. With no clear end to the pandemic, and a potential second surge of cases in the coming months, healthcare providers are preparing for these challenges. This program will cover several major developments that are shaping the healthcare landscape in the COVID-19 world, including the extraordinary actions implemented by federal and state government over the past several months which impact the future delivery of care. Topics will include the expansion of telehealth services, relaxation of cross-border licensing of healthcare professionals, CMS waivers of certain federal prohibitions including those related to the Stark Law and federal anti-kickback statute, 5th Amendment implications of taking private property to combat the pandemic, and potential insurance coverage issues and fraud-related concerns that have taken on new dimension in the wake of the unprecedented public health crisis.
