The Department of Justice, the Attorney General, the Securities and Exchange Commission, and the Office of the Inspector General are just a few of the law enforcement and regulatory agencies whose contact with a company, or its employees, can cause in-house and corporate counsel to panic. While few expect that they or their employees will be contacted by these agencies, it happens - and it happens more frequently than some might realize.

This presentation will go beyond a discussion of the practical considerations of crisis management for a deeper dive. The program will provide corporate counsel teams with the basic tools needed to prepare for and respond to the four most common ways companies and their employees encounter law enforcement: civil investigative demands, interviews, subpoenas, and search warrants. The panel will address each of these investigative tools, how in-house counsel should respond to them, and the ethical dilemmas that they raise.

Mr. Hille focuses his practice in litigation, with a particular emphasis on trial advocacy. His areas of concentration include insurance, healthcare law, professional liability and ethics, and white-collar criminal matters, including

those related to professional ethics.
