Published Cases

- In *Stahl v. Bauer Auto., Inc.* (2019), secured summary judgment on behalf of the defendant, an automotive repair facility, dismissing federal environmental liability claims asserted by a neighboring landowner under CERCLA. The ruling by the U.S. District Court for the District of New Jersey eliminated cleanup liability and litigation exposure for our client.
- In *Morgan Stanley Services Corp. v. NJDEP* (2011) before the New Jersey Appellate Division, successfully reinstated a favorable No Further Action (NFA) determination for a corporate client after the NJDEP improperly rescinded approval, preserving the client's ability to proceed with redevelopment and avoid

additional remediation obligations.
